- 4. Bidders must attach their valid ITF263 Tax clearance certificate.
- 5. Proof of Certification, Licensing or Accreditation as a service provider for auctioneering services.
- 6. 3 Reference letters from previous customers indicating services of the same nature.
- 7. Valid NSSA Clearance Certificate
- 8. Bidders must have at least 3 years providing similar services.
