- Bidders must note that if they put in more than one option only their main offer will be evaluated.
- Value added tax must be clearly and separately quoted.

- 2. Bidders must attach Value Added Tax Certificate
- 3. Bidders must attach their valid ITF263 Tax clearance certificate.
