- 2. Bidders must attach Value Added Tax Certificate

- 3. Bidders must attach proof of registration with Procurement Regulatory Authority of Zimbabwe (PRAZ) in the form of valid PRAZ certificate.
- 4. Bidders must attach their valid ITF263 Tax clearance certificate.
- 5. Bidders to provide proof of similar work done in the last 3 years e.g reference letters.
- 6. Bidders to submit proof of valid membership with CIFOZ, ZBCA
